### ADVANCING A STRONG GROUND GAME

#### A ground game is only as good as its capacity to deliver. This year, our ground game delivered.

Smart advocacy is intricate work that relies on constructing a sturdy and wide base in every community to succeed. For ten years, we've never stopped recruiting and training thousands of advocates to send a simple and clear message to lawmakers – meet the long-ignored school funding needs of low-income and minority students if you want to stay in office.

The odds against our success were great. Yet we were determined to never give up. We staffed an unwavering statewide coalition that was fueled by local advocates who relentlessly made the case for their students to their state lawmakers. These advocates extracted maximum value from a decisive state court decision on school funding equity and, with our support, strategically exerted the necessary pressure to produce bipartisan consensus for a history-breaking \$1.1 billion school funding increase and a new pattern for school funding that puts low-income students first.

There's no disputing that the earliest years of life present the most promise for nurturing healthy, vibrant minds. That's why the state dollars for great pre-k programs that help 67,000 children thrive are so important.

We would have preferred to push, this year, for more funds to meet the needs of the 40% of children still unserved by pre-k. Yet lawmaker interest in pre-k has waned since the pandemic and cuts to pre-k were in the offing.

Together with early learning advocates from across the state, we sounded the alarm and in just three months organized thousands of parents and early learning program staff to send letters, attend public events, and remind their state lawmakers of the benefits of pre-k.

Our advocacy was the reason that state lawmakers shifted from a position of likely cutting pre-k to a \$15 million increase.

Our experience teaches us that sometimes the best offensive is a strong defense.

### MOVING BOLD IDEAS FORWARD

## The COVID pandemic uncovered the depths of despair among youth, and it also made things worse.

In fact, 40% of children presenting in an emergency room for attempted suicide had never seen a mental health professional before trying to take their own life. And the pleas for help from caregivers and youth who've knocked on the doors of mental health care systems only to have them slammed in their faces convinced us to act. We learned from caregivers, youth, and mental health practitioners the root causes of lack of access to care and crafted with them an ambitious mental health policy agenda to solve the problem.

The results of our exhaustive research and our ambitious policy agenda are encapsulated in two groundbreaking reports, *Optimizing Medicaid to Improve Child and Youth Mental Health in PA* and *State Examples of Medicaid Optimization for Child and Youth Mental Health in Alignment with Recommendations for PA*. Our insightful research is rallying lawmakers, practitioners, public officials, and caregivers to focus on solutions and remove barriers to mental health services. The hunger for information, conversations, and the focus on actionable, bold, systemic policy change is galvanizing Pennsylvanians in every corner of the state. In just a few short months since the reports have been released, already thousands of Pennsylvanians have read them, attended convenings to discuss them, and enthusiastically shared with their networks.



## WINNING IN THE MARGINS

#### When children are sent to live in an institution because of neglect, abuse, or behavioral issues, they face grave risks of further physical and mental abuse.

That's why we never stop advocating to end the institutionalizing of children. But until we build the will for that policy, we must remain steadfast in making sure every possible layer of protection is in place for these children.

Thanks to our persistence, lawmakers are increasingly aware that locking up children causes them long-term harm and can make communities less safe because so many children leave institutions worse off than when they went in.

In response to our steady push to protect these children, Pennsylvania House lawmakers passed a bill to create a state level advocate charged with responding to pleas for personal protection from children when they are institutionalized. The House also rallied behind the bill that makes it illegal to chain or shackle children or put them in long-term solitary confinement. Our advocacy is custom-tailored to promptly respond to the urgent needs of children.





We listen to caregivers and youth who tell us the struggles they face and the solutions they know can make a difference.

We don't just hear what parents and youth have to say; we invest in them. We help them learn the ropes of advocacy and support them as they design their own advocacy campaigns. From school funding to better early developmental support to safer communities and a full suite of mental health services, caregivers and youth keep us focused on what matters most. Together, with us, parents are the catalysts for the change children need. We build a team of advocates ready to win. ADVOCACY MADE IT HAPPEN.

## BROADENING THE MESSAGE

We were founded in 1980 to respond to the abuse and threat that Black children faced from then-Mayor Frank Rizzo.

With more than four decades of experience challenging inequality, we know that only by addressing centuries of laws and policies that institutionalize racial inequality can we mend the harms of the past and spur progress for children.

Our Racial Equity Early Childhood Education Provider Council delved into the early learning gaps between children of color and their white counterparts. Together, we're demanding action to solve these disparities.

To end the practices that result in far too many Black and Hispanic children being expelled from early learning and child care programs, together with parents we are making headway to create new requirements that support stronger early intervention and child development supports so that all children thrive in these programs.

To combat racially biased practices in juvenile justice systems, we helped form the PA Youth Safety Coalition that is advancing reforms to end racial disparities and make our communities safer.

## WORKING THE INSIDE GAME

### **Career Related Learning Wins**

When we learned that high school students were sidelined from attending high school trade or skills programs because the state was decades behind on investing in these programs, we crafted a winning strategy to move things in the right direction. We quietly met with key senators we knew shared our goal of giving more high school students the chance to learn real world skills before they graduate and gave them the information they needed to win support from their colleagues for more resources.

The result: \$30 million more for these schools, the largest increase for technical high school education in a quarter of century. Career and technical high school programs and paid family leave give children a better shot in life.

### **Paid Family Leave Measure Advances**

We used that same political prowess to persuade lawmakers to vote for the Family Care Act, a bill that provides paid family and medical leave for working parents. Without fanfare, we connected lawmakers to businesses eager to see their employees have this benefit and to young parents hoping to stay in Pennsylvania, have children and remain employed. One by one, we build a coalition of Republicans and Democrats who voted yes on Paid Leave making Pennsylvania the first state where a Republican-controlled committee passed Paid Leave readying it for a vote on the Senate floor.

This work is not over. Our expertise in the inside game makes it possible for us to enact great laws that change the lives of children for the better.

Understanding the landscape in Harrisburg and maintaining relationships that keep us at the table when policies that impact children are being crafted is what we do. This work takes time and real connections. Staying true to our mission allows Children First to invest the time to advance policies and elevate the issues at the right moment to change outcomes.
